In support of strengthening student academic achievement, Bridesburg Elementary School receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). Section A: JOINTLY DEVELOPED

Bridesburg Elementary School will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

*A required Title I meeting is held during Back to School Night at which an invitation is extended to all parents and guardians to become a member of the Home and School Association and the SAC. All parents and guardians are invited to participate in discussion of the budget and school plan during the Annual Title I Winter meeting. This meeting was held on **January 30, 2025**. A parent input meeting was held on **March 12, 2025** to solicit parent input into the development of the Parent and Family Engagement Policy and School-Parent Compact.*

Section B: ANNUAL TITLE I MEETING

Bridesburg Elementary School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

*Annual Meeting: Held during the annual fall Back to School Night in **Fall 2025**. During this meeting, the administration will make a presentation to parents on the requirements of Title I, Part A, parents' rights under the law, the state's academic content standards and assessments, ways to work with educators as equal partners and how to monitor their child's progress. Parents/guardians will also receive the updated Parent and Family Engagement Policy and the School-Parent Compact and information about the school's curriculum and academic programs.*

Monthly Calendars will be provided as a method of communication identifying events scheduled for the month.

Conferences will be held every marking period to address teacher and parental concerns on students' academic achievement.

Emails to parents will go out on an as needed basis to help in communication.

ClassDojo will be utilized by classroom teachers to give feedback on assignments and progress.

Weekly communication folders (K-5) or student planners (6-8) will include any necessary information for parents.

Text messages with informational alerts will be sent periodically, as needed.

The Winter Title I Meeting was held on **January 30, 2025**.*

Bridesburg staff will be available to collaborate and coordinate with various organizations and parent groups to provide presentations and workshops about Title I, PA standards, and school district expectations in clear, simple language and, to the extent practical, in targeted languages. Bridesburg will disseminate materials from the Office of Teaching and Learning and other offices, including, to the extent feasible, translations to parents and caregivers that will be useful references at home. Parent can also access the Parent Resource Center at 440 North Broad Street. Bridesburg will coordinate with area pre-K programs to connect with parents of pre-K students and advertise our Kindergarten open houses in the spring.

Section G: BUILDING CAPACITY OF PARENTS

Bridesburg Elementary School will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and

Annual Meeting: During the annual Title I meeting, administration will make a presentation to parents on the requirements of Title I, Part A, parent rights under the law, the state's academic content standards and assessments, ways to work with educators as equal partners, and how to monitor their child's progress.
Parent Workshops will be offered throughout the 2025-2026 school year. Surveys will be distributed to parents to solicit feedback about topics that are of use to parents in supporting their child's learning. During report card conferences, held three times during the year, parents are able to get information about the school curriculum and how to support student learning at home. Weekly communication folders (K-5) or student planners (6-8) will be sent home to share necessary information for parents.

Section H: BUILDING CAPACITY OF SCHOOL STAFF

Bridesburg Elementary School will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

Professional Development will be held during a district PD day in the fall and winter where staff will be trained by administration in expected parent communication standards and methods of effective parent engagement. During this PD, results from the school level parent survey will also be shared with staff, with the assistance of parents.

Bridesburg Elementary School will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:
